ILPMP/SUPR Breaking Barriers with Opioid Treatment Program Reporting

Substance Abuse and Mental Health Services Administration (SAMHSA) announced in July of 2021 the adoption of the revised Confidentiality of Substance Use Disorder Patient Records regulation, 42 CFR Part 2. The adoption of this revised rule will reduce the barriers to care coordination and improve patient safety. Collaboration between both divisions, IDHS/SUPR (Division of Substance Use Prevention and Recovery) and IDHS/ILPMP (Illinois Prescription Monitoring Program) have made forward movement in improving healthcare outcomes while reducing barriers which, in turn, has increased patient safety in Opioid Treatment Programs. With patient consent, the ease of sharing information among providers will enable better, higher-quality care for those with Opioid Use Disorders.

Many drugs prescribed and dispensed by non-Opioid Treatment Programs (OTPs) could have life-threatening consequences if not properly coordinated with those prescribed and dispensed by OTPs. Therefore, it is necessary for OTPs to report, and to access, prescription drug records in the ILPMP, and to monitor accordingly.

Please join us virtually on August 31 at 10am, National Overdose Awareness Day in Illinois, as we discuss how impactful this law is for people with Opioid Use Disorders, ultimately reducing potential for overdose in Illinois.

SUBMITTERS UPDATE

Public Act 103-0477

WHAT IS IT?

Govenor Pritzker signed SB 285, Public Act 103 – 0477 into law, which clarifies requirements on what data fields need to be reported and the removal of outdated methods.



To clarify ...

Date prescription filled relates to the ASAP format DSP05 Date Filled (Required), this is the date that the prescription was prepared for the patient by the pharmacist. This is often called dispensing as the prescription is prepared and set aside for the patient.

Date dispensed relates to the ASAP format DSP17 Date Sold (Situational). This field is used to determine when a prescription left the pharmacy, not the date that it was prepared by the pharmacist. Use of this requires bi-directional communication between the pharmacy dispensing system and the point-of-sale system. The sale of the prescription would have to be reported back to the pharmacy dispensing system for reconciliation. This reporting function is not available in most pharmacy systems.



Removes the date the controlled substance is dispensed.

Removes outdated submission methods such as:

- (A) an electronic device compatible with the receiving device of the central repository;
- (B) a computer diskette;
- (C) a magnetic tape; or
- (D) a pharmacy universal claim form or Pharmacy Inventory Control form.

WHY IS IT BENEFICIAL?



Removing "Date(s) Dispensed" field is cost effective for all. This is not a data field available within the American Society of Automation in Pharmacy's national standards.

THE DISPENSER MUST ELECTRONICALLY TRANSMIT THE FOLLOWING PRESCRIPTION DATA:

- 1. The recipient's name and address.
- 2. The recipient's date of birth and gender.
- 3. The national drug code number of the controlled substance dispensed.
- 4. The quantity of the controlled substance dispensed and days supply.
- The dispenser's United States Drug Enforcement Administration registration number.
- 6. The prescriber's United States Drug Enforcement Administration registration number.
- 7. The dates the controlled substance prescription is filled.
- 8. The payment type used to purchase the controlled substance (i.e. Medicaid, cash, third party insurance).
- 9. The patient location code (i.e. home, nursing home, outpatient, etc.) for the controlled substances other than those filled at a retail pharmacy.


